Our Admin team began discussion with the first version of this document in June. We have participated in the Deschutes County weekly Zoom calls when they are offered. Our parent community has been surveyed. Regular updates have been communicated to our Trinity families with the opportunity for Q & A. The Northwest (NOW) District of the Lutheran Church-Missouri Synod (LC-MS), our church body, has had regular administrative updates via Zoom calls. We also have participated with the Association of Lutheran Secondary Schools (ALSS) and other scenario planning groups as they have offered training for leading through the pandemic. Many internal and external conversations have occurred, and adjustments have been made at each revision of the document.

Current State of Oregon and Deschutes County metrics prohibit our school from opening in-person/on-site. We are choosing to open via distance learning to allow our families and our staff adequate time to prepare and implement a quality distance learning environment. We do plan to implement the Limited In-Person Instructional Plan as well, per the guidelines, to better serve our students and families. We will re-open to in-person/onsite instruction for all grades at the beginning of the quarter, pending the metric measurements are met and the necessary permissions have been received.

Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the Ready Schools, Safe Learners guidance.

Trinity Lutheran School will open remotely on September 1, 2020. Our plan is to return to On-Site Learning after October 30, 2020 provided the state guidelines for COVID cases per 100,000 people and the test positivity rates for Deschutes County are in acceptable ranges.

In preparation for opening, the learning spaces on campus have been identified and modified where necessary, to meet the 35 sq. ft per person social distancing requirement. Additional staff has been hired to support the enrollment cohorts that will be required to meet the state guidelines. Additional cleaning and janitorial staff have been hired to meet the sanitation guidelines. PPE supplies have been purchased and installed/provided to meet the state guidelines for in-person instruction.

Faculty and staff have been in-serviced and trained to provide a safe environment for students entering and exiting the building and maintaining proper social distancing among the students. Campus space has been reconfigured to meet safety guidelines for students or staff who may need to be sent home due to symptoms.

Cohorts have been designed to provide for limited opportunities for exposure in the event of a positive COVID case on campus. Devices have been purchased for grades KDG-2 (iPads) and grades 3-5 (Chromebooks) in the event that instruction would need to shift between on-site/in-person and online environments. Students in grades 6-12 have access to MacBook Airs either through school loaned or personally purchased.
